I recognize that the operation of any MINI after the vehicle performance alterations and or performance parts additions to my MINI is an inherently dangerous activity with a risk of damage or loss of the MINI and serious injury or death to my self and/or to my mechanics working with me. I understand that these risks include possible damage to the vehicle drive-train, chassis, electrical systems, mechanical systems, suspension and under-carriage, body, interior/exterior structures or loss of the manufacturer warrantee but are not limited to: *improper use of floor car jack and its secure positioning, secure car chassis stands placements, wheel blocks, breaks and or shift gear engagement, improper use of OEM instruction to install, incomplete or improper restoration of any and all removed parts as per OEM instructions, failed work completion review for safe installation process, car body damages due to negligence on any ones part, operational testing prior to engage in driving the car* **Garage Party**.
